



## 2022 Meeting/Convention Ticket Program

This Ticket Order Form is for meetings and convention groups only. There is a 10-ticket minimum pre-purchase required to place an order. 100% payment is required for all orders. Ticket order forms must be returned 30 days prior to date of visit in order to confirm theme park reservations (which are limited and subject to availability).

All attendees visiting the *Disneyland*® Resort will be required to follow all health and safety measures required by the State of California, local health officials and the *Disneyland*® Resort.

Please complete this ticket order form and send it to your *Disneyland*® Resort representative\*.

Please allow two (2) weeks (from the order date) to receive your tickets. Your payment must accompany the order form, and the payment must be made with either a company/organization check, ACH or credit card. All prices are in US dollars. Orders are not accepted until confirmed by Disney. All prices are subject to change before confirmation of your order.

These specially priced tickets may be purchased only for individuals attending the meeting or convention set forth below (the “**Group Visit**”) for use **ONLY** by attendees and their travel companions during their stay. All theme park tickets purchased hereunder are non-refundable, non-transferable, and non-exchangeable, subject to the terms set forth below. You agree that all theme park tickets purchased here under will be distributed to attendees before the end of the Group Visit or returned to us as set forth in the following sentence (regardless of refund eligibility), and you may not retain ownership or (except as to tickets to be returned to us within the thirty (30) day period referenced in the following sentence) possession of any tickets after the end of the Group Visit. You must advise us in writing (email is acceptable), before the end of the Group Visit, of the number of unused tickets to be returned and physically deliver such tickets to us no more than thirty (30) days after the end of the Group Visit. You may request a pro rata refund of the total theme park tickets purchased hereunder (the “**Total Fees**”) only if (a) all remaining tickets after distribution to attendees are returned, and such returned tickets are wholly unused; (b) you advise us in writing before the end of the Group Visit of the number of unused tickets to be returned; and (c) you physically deliver such tickets to us no more than thirty (30) days after the end of the Group Visit (i.e., we must receive such tickets by such date). No refund for any tickets will be provided if any of these requirements is not satisfied. The refund amount will be equal to the percentage of tickets returned multiplied by the Total Fees, **but in no event shall the refund exceed ten percent (10%) of the Total Fees.**

### 2022 Meeting/Convention Ticket Program Terms & Conditions

1. Disney reserves the right to contact ticket holders to request that they provide their meeting/convention registration confirmation. If it is discovered that the ticket holder or their travel companion is not participating in the Group Visit, it will be considered a violation of these terms and conditions, and the ticket will be de-activated and will not be eligible for a refund. Parking not included. Guests under age 14 must be accompanied by a guest 14 or older to enter the *Disneyland*® Resort theme parks.
2. The State of California strongly recommends that all Guests be fully vaccinated or obtain a negative COVID-19 test prior to entering the *Disneyland*® Resort. Guests should visit [Disneyland.com/Updates](https://www.disneyland.com/Updates) for important details and what they need to know before visiting the *Disneyland*® Resort—including the latest information on required face coverings.
3. Tickets, and associated features and entitlements such as the *Park Hopper*® entitlement, are nonrefundable, nontransferable, revocable and may not be redeemed for cash. Each ticket admits one person. Guests with a *Park Hopper*® ticket and an appropriate park reservation may cross over and switch between parks on the same day beginning at 1:00 PM. They must make a park reservation for the first theme park they wish to visit to begin their day and must enter that first park prior to visiting the other park. The ability to visit a park is subject to the park's capacity limitations. At this time a park reservation is not required after the first park, however, reservation requirements are subject to change.
4. To enter one of the parks, each Guest (ages 3 and older) is required to have a theme park reservation in addition to a valid ticket for the same park on the same date. Park reservations are limited and subject to availability, restrictions, change and cancellation at any time. Park reservations are non-transferable and void if transferred or sold. Park admission is not guaranteed.
5. Tickets may not be sold, bartered nor exchanged for goods, services or benefits. Each ticket, with applicable park reservation, admits one Guest. Tickets are nontransferable and must be used by the same person on any and all days. Valid photo identification confirmation, applicable ticket and valid theme park reservation are required for readmission to the same Park and, if applicable, crossover to the other Park. Disney is not responsible for lost or stolen tickets or property. Theme parks, restaurants, attractions, entertainment, products, services and offerings may be modified or limited in capacity or availability; are subject to change, closure, cancellation and discontinuance without notice due to rehabilitation, refurbishing, capacity, seasonal considerations, weather, low demand, government or other authority guidance or order, pandemic-related restrictions, special events, or any other reason without liability to the Released Parties, named below; and are not guaranteed. No refunds given for any such changes or cancellations.
6. Tickets are not valid for special or premium events or other activities which are separately priced, or for special events that are not open to the general public. It is agreed between the Released Parties, named below, and ticket users that all claims for injury or loss arising incident to presence on the Released Parties' property shall be litigated in Orange County, California. Disney reserves the right to refuse admittance to any person or persons.
7. Disney shall have the right to cancel any tickets or entitlements at any time and for any reason, and provide an applicable refund. Tickets are nonrefundable unless cancelled by Disney. If Disney cancels a ticket due to misconduct of the holder, no refund shall be due.
8. Due to various restrictions and limitations, tickets cannot be shipped to all locations. Title to the tickets passes upon delivery of the tickets in Anaheim, California to the shipper. Recipient is responsible for any duty or custom charges or expenses.

9. 1-day tickets must be used by the dates set forth on such tickets and are valid for dates in the same or lower tier. Multi-day tickets are only valid for a 14-day validity range based around the date of the Group Visit. Each day of use of a ticket constitutes one full day of use. Multi-day tickets must be used within the 14-day validity range.

10. All features and entitlements of tickets are subject to change without notice. Other restrictions may apply. All sales of tickets and entitlements take place in and are consummated in the State of California. These terms and conditions are subject to change, and notice of such change will be given if and when revised terms and conditions are issued.

11. Disney reserves the right to require a Guest to leave if they are (i) not properly wearing an approved face covering, (ii) using profanity or offensive language towards Disney Cast Members or other Guests and/or (iii) violating any other Park Rules.

12. These terms and conditions shall be governed by the laws of the State of California. The Released Parties are: Walt Disney Parks and Resorts U.S., Inc.; Disney Destinations, LLC; Disney Vacation Development, Inc.; Disney Vacation Club Management LLC; and their respective parents, subsidiary, and other affiliated or related companies, and all officers, directors, employees, shareholders, members, agents, contractors, sub-contractors, representatives, successors, assigns, insurers, and volunteers of each of the foregoing entities.
